

43. SPRINT BUSINESS SIMPLE RATE

1. Description

The Sprint Business Simple Rate<sup>SM</sup> plan is designed to meet the communications needs of small business customers. Dial-1, Directory Assistance, operator services, toll free, and Switched Data Services (SDS) are available. Minimum usage levels of \$30.00 and \$50.00 are available. For a monthly recurring charge of \$5.00, a customer will receive discounted international Dial-1 and FONCARD rates to various countries as found in Section 43.7. Customers who subscribe to this service are required to receive their bill from Sprint. The business rates for the Presubscribed Line Charge and the Carrier Universal Service Charge will apply. In addition, other taxes and fees may apply.

2. Monthly Minimum Usage Levels

A customer may choose a \$30.00 or \$50.00 monthly minimum usage level. When a customer's total monthly long distance charges do not meet their monthly minimum usage level, they will be assessed the difference between their total long distance charges and their monthly minimum usage level. The \$5.00 monthly recurring charge applicable to the Sprint Business Simple Rate International Discount Plan does not apply to a customer's total monthly long distance charges.

3. Interstate Usage Rates

The following interstate rates are billed in 6-second increments with a 18-second minimum.

1. Dial-1

The following rates apply to interstate Dial-1 service. Dial-1 interstate service is available to customers in the U.S. Mainland, Hawaii, Puerto Rico and the U.S. Virgin Islands. Interstate calls may terminate to a state, U.S. possession or territory that is different from the originating location. Terminating locations include the U.S. Mainland, Alaska, American Samoa, CNMI, Guam, Hawaii, Puerto Rico, and the U.S. Virgin Islands unless otherwise specified in Schedule No. 11.

2. FONCARD

Interstate calls may terminate to a state, U.S. possession or territory that is different from the originating location. Terminating locations include the U.S. Mainland, Alaska, American Samoa, CNMI, Guam, Hawaii, Puerto Rico, and the U.S. Virgin Islands unless otherwise specified in Schedule No. 11.

Interstate toll free calls may terminate to the U.S. Mainland, Hawaii, Puerto Rico, and the U.S. Virgin Islands.

For a monthly recurring charge of \$5.95, a customer will receive the [Sprint Business Simple Rate International Discount Plan](#) rates. For countries not included in this plan, the [Sprint Business Simple Rate Dial-1 and FONCARD](#) rates apply. FONCARD calls will be assessed a [Sprint International FONCARD Surcharges Option 5](#) per call surcharge.
