
42. SPRINT SMALL BUSINESS UNLIMITED SOLUTIONS#SM**

Sprint Small Business Unlimited Solutions is an add-on to the Sprint Small Business Unlimited Solutions incumbent local exchange service. The service is designed to meet the needs of small business customers.

A customer must subscribe to Sprint Small Business Unlimited Solutions in-state long distance service and incumbent local exchange service. In addition, the customer must subscribe to: 1) Sprint Priority Solution Package and Voicemail, 2) the Sure Solution II Package and Voicemail, or 3) the Rotary Classic Solution Package and Voicemail. The Sprint Priority Solution Package, the Sure Solution II Package, and the Rotary Classic Solution Package may or may not include a separate charge for extended local calling.

A customer who subscribes to this service will pay one monthly recurring charge (MRC) per ANI for unlimited Dial-1 long distance, interstate calls. Additional MRCs for in-state long distance service and for local service apply. In addition, a customer who subscribes to a Sprint Small Business Unlimited Solutions: 1) may not have a phone line classified as a "residential", "public" or "semi-public" line and 2) may not have a phone line in housing associated with educational institutions. Dial-1 local and long distance service provided under the Sprint Small Business Unlimited Solutions bundled service offerings applies on a per line basis only and does not include the following: 1) usage associated with multi-party conference calls; 2) FONCARD calls; 3) calls which are pay for use, including calls to 900, 976, 555 and 700 numbers; 4) calls to Directory Assistance; 5) calls which involve an operator service, including busy line verification, emergency interrupt, person to person or station to station calling, and intercept call completion; and 6) toll free service.

Use of any feature, including but not limited to call forwarding, on a planned and continuing basis to allow an originating caller to avoid long distance charges is prohibited.

A customer may not use this service for connection to the Internet or other data service, (including a significant number of facsimile transmissions or data usage per month), or for any other use that does not involve a person-to-person conversation or voice message, e.g. auto dialer lines and call center lines. A customer may not have more than three lines per billing location with this service. Customers with multiple locations must have each location billed on a separate account.

If Sprint determines the customer has violated the terms and conditions of the service, the customer will be assessed a \$500.00 charge per line. In addition, the customer's long distance service will be suspended.

Sprint may deny, for any lawful reason, a customer's request for service, or limit or allocate the facilities available to or utilized by any service, if necessary, to manage its network in an efficient manner; meet reasonable service expectations; furnish service to existing; and future customers based on forecasted customer requirements; or for any other lawful reason.

Without notice, Sprint may (consistent with governing laws or regulations) block traffic to local telephone exchanges ("NXX exchanges") individual telephone stations, groups or ranges of individual telephone stations, or calls using certain customer authorization codes, whenever Sprint deems it necessary to take such action to prevent: 1) the unlawful use of service; 2) nonpayment for service; 3) the use of service in violation of this schedule; or 4) network blockage or the degradation of service furnished to the customer or other customers.

A customer who wishes to have toll free service on a Sprint Small Business Solutions Unlimited line must purchase the service from a separate small business, long distance plan.

Domestic Dial-1 and FÖNCARD calls are billed in 6 second increments, with a 18 second minimum. International calls are billed in 6 second increments, with a 30 second minimum.

Sprint will prorate all charges and associated usage in the initial month and last month of service based on a 30-day month.

1. Interstate Rates1. Dial-1

For a MRC of \$15 per ANI, a customer will receive unlimited interstate calling. Dial-1 interstate service is available to customers in the U.S. Mainland, Hawaii, Puerto Rico and the U.S. Virgin Islands. Interstate calls may terminate to a state, U.S. possession or territory that is different from the originating location. Terminating locations include the U.S. Mainland, Alaska, American Samoa, CNMI, Guam, Hawaii, Puerto Rico, and the U.S. Virgin Islands, unless otherwise specified in Schedule No. 11.

2. FÖNCARD

The per minute rate and per call surcharge found in [Sprint Business Flex](#), Section 13.3.10.4 apply.

2. International Usage Rates1. Dial-1 and FONCARD

[Sprint Business Flex With All Calls All Day V](#) Dial-1 and FÖNCARD rates apply. FONCARD calls will be assessed a \$1.40 per call Connection Fee.

2. Sprint International Access

[Sprint Business Flex With All Calls All Day II International Access Rates](#) apply for Sprint International Access FONCARD calls. A \$1.40 per call surcharge applies per call. For Sprint International Access Collect calls [Sprint International Access Collect Rates](#) apply. In addition, a [Sprint International Access Collect Surcharge](#) applies per call.

3. International Access Country-to-Country Calling (Switched Access)

Sprint International Access Country-to-Country Calling allows a customer to place calls between and within various zones. The [Sprint Business Flex With All Calls All Day II International Access Country-to-Country Access Rates](#) apply. A \$1.40 per call surcharge also applies.
