

“#SPRINTPOKESTOP #BOOSTPOKESTOP SWEEPSTAKES”

OFFICIAL RULES

NO PURCHASE REQUIRED TO ENTER OR WIN

1. **ELIGIBILITY:** “#SprintPokeStop #BoostPokeStop Sweepstakes” (the “Sweepstakes”) is open only to legal residents within the United States who are 14 years of age or older. **ANY ENTRANT WHO IS UNDER 18 MUST HAVE PERMISSION OF PARENT OR LEGAL GUARDIAN TO ENTER.** Employees of Sprint Communications Company L.P., its affiliates and each of their respective employees, shareholders, officers, directors, agents, members, successors and assigns, or other companies associated with the promotion of the Sweepstakes, as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. The Sweepstakes is subject to federal, state, and local laws and regulations and is void in Puerto Rico and where prohibited.

4. **SWEEPSTAKES PERIOD:** The Sweepstakes begins on December 19, 2016 at 9:00 am ET and ends on January 8, 2017 at 11:59 pm ET (the “Sweepstakes Period”). Entries that are submitted before or after the Entry Period will be disqualified.
5. **HOW TO ENTER:** Visit a participating Sprint or Boost store, take a photo inside and share it on your Twitter social network page with the hashtag #SprintPokeStop or #BoostPokeStop along with #Sweepstakes for a chance to win one of the 100s of sweepstakes prizes.

Limit one entry per person for the duration of the Sweepstakes Period regardless of method of entry. Any entries attempted through the use of agencies or robotic, repetitive, automatic, programmed, or similar methods will be void.

SPONSOR'S RIGHTS TO ENTRIES: By submitting an Entry, you grant the Sponsor the unconditional and perpetual right and permission to copyright, reproduce, encode, store, copy, transmit, publish, post, broadcast, display, publicly perform, adapt, modify, create derivative works of, exhibit, and otherwise use the Entry (with or without using the your name) in any media throughout the world for any purpose, without limitation, and without additional review, compensation, or approval from you or any other party. By submitting an Entry, you further agree not to instigate, support, maintain, or authorize any action, claim, or lawsuit against the Sponsor, or any other person, on the grounds that any use of the Entry, or any derivative works, infringe any of your rights, including, without limitation, copyrights, moral rights. You further acknowledge that the Sponsor is

in no way obligated to publish or use your Entry in any way. Nothing herein shall constitute an employment, joint venture, or partnership relationship between you and the Sponsor. In no way are you to be construed as the agent or to be acting as the agent of the Sponsor.

6. **DRAWING:** On the drawing date of January 11, 2017, two hundred six potential winners will be randomly selected from the entries collected. The odds of being selected depend on the number of entries received. The Sponsor will attempt to notify the winners within seven days of the drawing by Twitter handle and/or email provided by the potential winner on the sweepstakes entry. If a potential winner cannot be contacted within 24 hours after the first attempt to contact him/her, the Sponsor may select an alternate winner in his/her place at random from the remaining entries.
7. **REQUIREMENTS OF POTENTIAL WINNERS:** A potential winner may be required to complete and return an affidavit of eligibility and liability/publicity release (the "Affidavit/Release") within 24 hours of being notified. If a potential winner fails to sign and return the Affidavit/Release within the required time period, he/she will be disqualified and an alternate entrant may be selected in his/her place in a random drawing of all entries received.

Any attempt by any person to undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, the Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Failure by the Sponsor to enforce any provision of these Official Rules shall not constitute a waiver of that provision.
